Victory! Tentative Agreement Includes 3% ATBs Annually and Wage Equity for All by the End of Contract for All Greater Sacramento ESC Local 20 Represented Locations

Our actions in the past months were key to our success in reaching an agreement. Petitions, Informational Picketing, wearing Union colors, and showing our willingness to strike, if necessary, gave the bargaining team the power it needed to bring home a Tentative Agreement on August 9 that includes:

- 3% wage increase Across the Board (ATB) every year for five years;
- All Local 20 units, including Saint Joseph's, unified under one contract;
- Wage Equity:
 - Woodland Radiology, POS Schedulers, and Lab Assistants: Full implementation of the Woodland Equity Study immediately following ratification;
 - Mercy and Woodland Laboratory Professionals: New wage scale comparable to Kaiser complete by January 2020, first step of up to 3% for eligible employees immediately following ratification;
 - O Saint Joseph's: Structured salary schedule with clear annual steps fully implemented by August 2022, first step of up to 3% for eligible employees immediately following ratification;
- Increased annual tuition reimbursement to \$5,250 for Full-Time employees;
- Healthcare: All employees will remain on their current plan. Everyone, who is not already, will begin paying new healthcare rates in 2020.
- Many other improvements in contract language.

Your volunteer Bargaining Committee was resilient and unified, working long hours, many on their own time to achieve this agreement with strong wage increases and many other benefits. Thank you to the Bargaining Committee and *all* the union members who stood strong and took action to get the contract we deserve!

Your Bargaining Team Unanimously Recommends a "YES" Vote.

Only full members, not Agency fee payers, are eligible to vote, with the exception of St. Joseph's workers. All ESC Local 20 represented St. Joseph's workers are eligible to vote on their first contract.
