ESC Local 20 Executive Board Authorizes Sympathy Strike Vote from September 3-16

Kaiser has been bargaining in bad faith and acting unlawfully during local negotiations with our brothers and sisters in SEIU-UHW. Now ESC Local 20 members in Clinical Labs, Optometry, Genetics, and Home Health Therapy are preparing to stand shoulder-to-shoulder with them by authorizing the ESC Local 20 Executive Board to call a sympathy strike.

37,000 SEIU-UHW members have already authorized their bargaining team to go on an Unfair Labor Practice Strike of up to seven days to protest Kaiser's unlawful actions, which are creating an unlevel playing field and ultimately interfering with SEIU-UHW's ability to maintain their members' standard of living, retirement, and job security.

If Kaiser can get away with this behavior and bad faith bargaining with SEIU-UHW, where will it stop?



Voting YES to authorize a sympathy strike shows Kaiser that ESC Local 20 members will not stand for illegal behavior towards our brothers and sisters in SEIU-UHW.

Your Executive Board is unanimously recommending a YES vote to authorize a sympathy strike with SEIU-UHW's Unfair Labor Practice Strike, if called.
