Dear Mr. Harland:

In accordance with the provisions of Subsection 7.4(f) of the ESC Collective Bargaining Agreement and the requirements of LA 24-14-ESC (9/80 Master Agreement), the Company is proposing to change the current work schedule(s) of employees to allow a 9/80 work schedule with a fixed Regular Day Off (RDO) every other week as follows.

This agreement cancels and supersedes any prior 9/80 alternative work schedule agreements.

This agreement proposes to establish 9/80 alternative work schedules for New Business Representatives, Senior New Business Representatives, and Industrial Power Engineers. This new alternative work schedule will start at the beginning of a new payroll cycle and shall commence on June 1, 2025.

Defined Workweek

The new 9/80 seven-day workweek schedules shall be defined as:

- Friday 10:00 a.m. and ends on the following Friday at 9:59 a.m. for a schedule starting at 6:00 a.m.
- Friday 10:30 a.m. and ends on the following Friday at 10:29 a.m. for a schedule starting at 6:30 a.m.
- Friday 11:00 a.m. and ends on the following Friday at 10:59 a.m. for a schedule starting at 7:00 a.m.
- Friday 11:30 a.m. and ends on the following Friday at 11:29 a.m. for a schedule starting at 7:30 a.m.

Employees, regardless of work schedule, may take either a 1/2-hour unpaid lunch or 1-hour unpaid lunch. The sample schedules provide for a 1/2-hour lunch. Desired unpaid lunch duration of 1/2-hour or 1-hour must be communicated to supervisor in advance. If an employee takes a 1-hour lunch their schedule will be extended by 1/2-hour at the end of the day. Once an employee's shift or schedule is set it may only be changed once every six (6) months but no more than twice per year.

If employees do not choose Schedule 1 or Schedule 2 for the 9/80 alternative work schedules listed above, they will be required to work a five-day, eight-hour work schedule starting at either 6:00 a.m., 6:30 a.m., 7:00 a.m. or 7:30 a.m.

Management has the right to staff work schedules based upon business needs.

Either the Company or Union reserves the right to return from the 9/80 alternative work schedule to the five-day, eight-hour work schedule starting at either 6:00 a.m., 6:30 a.m., 7:00 a.m. or 7:30 a.m. by giving a 30-day written notice. The effective date for a new work schedule will take place on the first week of a new pay cycle.
